### **Position purpose**

The Project Manager will provide day to day project leadership and coordination for the ARC Linkage Grant "Does self management increase the effectiveness of vocational rehabilitation for chronic compensated disorders?" The grant will investigate the effectiveness of adding 'self management' to vocational rehabilitation for chronic compensated disorders.

The ARC Linkage Projects scheme encourages and develops long-term strategic research alliances between higher education organisations and collaborating organisations, which lead to significant national economic, environmental, social and cultural outcomes. The scheme supports the work of innovative researchers and contributes to new opportunities for exciting research and discoveries for the benefit of all Australians.

The Project Manager will manage the infrastructure required to support the research methodology, monitor progress towards milestones and take action, with the Research Team, to ensure completion on time and on budget.

It is envisaged that the Project Manager have experience managing research projects in a health related environment. In addition, the Project Manager will assist Chief Investigators to analyse and prepare reports and papers, develop evaluation instruments, analyse qualitative research on impact outcomes, and coordinate national workshops.

**Reporting Line**: The position reports to the Director, MIRI but will have a close working relationship with the CEO of ISCRR who is the Chief Investigator of the grant and the Research Manager, ISCRR.

### **Organisational context**

It is a multidisciplinary institute that aims to facilitate research and best practice that improves outcomes in relation to occupational health and safety, rehabilitation and compensation practice.
